


Canvas provides a secure platform and common tools for organizing course content and interacting with students.



Canvas is connected to other systems, streamlining access to various technologies in the context of a course, without separate logins or manually granting access.



Canvas Accounts

Requirements

- 900-number
- Florida Tech Email Address

Notes

- Automatic, very few problems
- Admit students do not have Florida Tech emails (no Canvas)
- Source: IBM LDAP Directory
- Duplicate account errors (staff/faculty, IT resolves)
- Suspended accounts (students, more info later)

Canvas Enrollments & Teaching Assignments

Requirements


- Course with CRN for current term
- Instructor of Record assigned
- Student registered

Notes

- It has to be right in PAWS before it will be right in Canvas
- Syncs every two hours
- Drops are set to Inactive, remain visible on rosters
- Crosslisted courses show parent section ID (causes some confusion)

Start of Semester Recap:

- Courses are in PAWS.
- Students have enrolled.
- Faculty have been assigned to teach.
- The Canvas course rosters are ready.
- We're ready for a great school year!
- (Cat picture unrelated.)



INTERMISSION

Canvas Suspended Accounts Process

- A common source of confusion
- Affects students who do not pay on time
- Ambiguous error message (...“no account”...)
- Students looking for a work-around get the run-around

Canvas Suspended Accounts Process

- Student Accounting owns the process
- Students with overdue balances are warned
- Student who do not pay on time are suspended from Canvas
- Students cannot access Canvas while suspended
- Students remain on rosters *and appear active to instructors*
- IT departments cannot look up balances or restore accounts
- Students are restored by Student Accounting upon payment
- Students who still do not pay are eventually dropped
- New: Canvas error message to be replaced with info page

 - How are students doing in the course?
(How do they know?)
 - How can students who aren't doing well improve?

 - Early Alerts and Advising
(How to recognize and support students in need as soon as possible!)

Instructional Technology Consultation

- **We can set up Canvas to match the grading policy on a syllabus.**
- We can help faculty ensure they are meeting university policy requirements in their courses.
- We can guide faculty to use Canvas effectively for what they teach.
- **We can only do this if faculty request our help.**

Early Academic Alerts – In the Past

- Limited to CHM1101 and MTH1001
- Starting Week 4
- IT in charge of coordinating message content per course
- IT in charge of scheduling messages and setting recipients
- IT messages only routed to advisors once, prior to WF date

Early Academic Alerts – Perks

- CHM1101 and MTH1001 are strong indicators for at-risk students
- At-risk students receive extra nudges about tutoring opportunities
- Advisors able to assess performance before midterms
- Data collected can be used for aggregate/longitudinal analysis

Early Academic Alerts – Pitfalls

- Other courses may also be strong indicators of academic risk
- Week 4 may be too late to remediate or change paths
- Instructors do not need alerts about their students
- Advisors not equipped for ongoing support
- Excess administrative overhead
- IT sends the messages with the intent of connecting students to instructors/resources. It would be better for instructors to message students directly, triage for course-specific resources.

Early Academic Alerts – Goals

- Extend Early Academic Alerts to courses beyond Gen-Chem and Calc 1
- Incorporate new Advising Model in Data Dissemination
- Describe and Adjust Scopes of Ownership for Scalability and Efficiency
- WEAVE Assessment Goal: Improve aggregate utilization of Canvas tools commonly employed for student-success (gradebook messaging and new analytics) by 10%

Early Academic Alerts – This Fall

- [New Analytics](#) work for any course with grades
- Messages can be sent as soon as grades are submitted
- Instructors/Coordinators in charge messaging their students
 - Very few clicks!
 - Instructors use [New Analytics to send messages](#) based on course grades and activities.
- IT messages new Advisors with aggregate data from all courses for all students starting in Week 2
- Advisors to serve as primary point of contact for students
- Advisors to escalate student-issues as needed

Big Recap

- PAWS data feeds Canvas (check PAWS first!)
- Canvas connections streamline access through courses
- Student Accounting can block students' Canvas access
- [ONLY] Student Accounting can restore blocked Canvas access
- The LMS Policy sets the foundation for student success
- Faculty need to use the Canvas gradebook
- Instructional Tech can set up Canvas gradebooks for faculty
- Faculty can send academic alerts in ANY course
- Advisors will get weekly Canvas grade and activity reports to support student success
